Public Meeting

The Virginia Department of Transportation (VDOT) welcomes you to the public information meeting on plans to replace the Dundas Road (Route 641) bridge over G Road and add a pedestrian sidewalk in Chesterfield County.

This public information meeting is being held to provide an opportunity for individuals or organizations to give VDOT comments and/or suggestions on the proposed project. VDOT strives to ensure that all members of the community have the opportunity to participate in public decisions on transportation projects and programs affecting them.

Civil Rights

Representatives from VDOT are present to discuss the project and answer your questions. It is the responsibility of VDOT to ensure that all members of the community are afforded the opportunity to participate in public decisions on transportation systems and projects affecting them. Project Overview



The structure runs over G Road and the railroad.

Anticipated cost – \$11 million

Purpose – Replace the bridge over G Road and add a pedestrian sidewalk

From – Meadowdale Boulevard (Route 770)

To – Strathmore Road (Route 1607)

Total length – 0.34 miles

Anticipated start – Fall 2021

PROJECT DESCRIPTION

The primary purpose of this project is to replace the Dundas Road bridge over G Road on the existing alignment. The current bridge was built in 1961. Pedestrian accommodations will also be added.

During construction, westbound Dundas Road will be reduced to one lane and eastbound travelers will be detoured to Chippenham Parkway at Meadowdale

Boulevard. Following right of way acquisition in fall 2019, construction is expected to begin in fall 2021 and is anticipated to be complete in spring 2024.

According to 2017 traffic counts, the Dundas Road bridge carries approximately 7,100 vehicles per day.

Environmental Review

This project is currently being reviewed by VDOT environmental specialists and will be coordinated with appropriate federal, state and local agencies as part of the environmental review process including the National Environmental Policy Act (NEPA). A Programmatic Categorical Exclusion is anticipated for this project. VDOT anticipates the NEPA document will be completed in July 2018.

Right of Way

The construction of this project will not require the displacement of any families, businesses or non-profit organizations. However, construction is expected to impact as many as six properties. Property owners will be provided detailed information regarding impacts to their property. Utility easements are anticipated with this project. Information about right of way acquisition is discussed in VDOT's brochure entitled "Right of Way and Utilities: A Guide for Property Owners and Tenants." VDOT right of way representatives will contact the affected land owners.
