Purpose – Improve naval access and provide traffic relief to Terminal Boulevard, Hampton Boulevard and surrounding roadways

From – 0.546 miles east of Hampton Boulevard

To – Intermodal Connector

Total length - 0.78 miles

Improvements – Design and construct a new interchange at the eastern side of the I-564 Intermodal Connector connecting to the residences and facilities in Camp Allen area. The project includes a new bidirectional bridge spanning the eastbound lanes and rail tracks, and also the extension and widening of the existing Ingersol Avenue.

State Project: 0564-122-542, Federal Project: STP-5B03(370), UPC: 123154

PROJECT DESCRIPTION

The purpose of this project, located in Norfolk, is to improve Naval Station Norfolk's base access and provide traffic relief to Hampton Boulevard, Terminal Boulevard and surrounding roadways by directing vehicles and heavy trucks away from local surface streets. The proposed plans for the eastern intersection create a new interchange connecting the Naval Station's residences and facilities in the Camp Allen area directly to the Interstate 564 (I-564) Intermodal Connector for improved access to I-564, Naval Station Norfolk entrance gates 5 and 6, and Hampton Boulevard. The eastern intersection will connect to the Intermodal Connector approximately 0.2 miles west of I-564, encompassing a total of 0.78 miles of roadway.

The eastern intersection project includes:


- Extension of existing Ingersol Avenue toward the Intermodal Connector with construction of 0.29 miles of new bi-directional roadway.
- Construction of a new bridge to connect traffic to and from Ingersol Avenue to the Intermodal Connector. The bridge will span the eastbound lanes of the Intermodal Connector along with the existing and future railroad tracks of Norfolk Southern Railroad and Portsmouth Beltline.

- Widening and reconstruction of 0.49 miles on the existing Ingersol Avenue
- Construction of acceleration and deceleration lanes on Intermodal Connector for traffic merging
- Intersection improvements at Ingersol Avenue and Elementary Drive
- Drainage improvements and stormwater management facilities
- Signage and pavement marking
- Utility relocations
- Temporary lane closures and traffic shifts may be necessary during construction.

Access to all facilities and residencies will be maintained during construction.

The design of this project is in compliance with the Stormwater Management Act, all Bird Air Strike Hazard regulations, stormwater regulations and VDOT's standards and specifications approved by the Virginia Department of Environmental Quality. Potential impacts to the flood plains will be evaluated and addressed on this project. The construction of this project will comply with water quality and quantity standards as outlined in the construction general permit.

Environmental Review

In cooperation with Federal Highway Administration (FHWA), VDOT is evaluating the environmental impacts of the Air Terminal Interchange Eastern Intersection project in Norfolk in the form of an Environmental Assessment (EA) document. An EA was prepared by the Department of Defense (DoD), Department of the Navy (Navy) for the Intermodal Connector (IMC) and the Air Terminal Interchange (ATI). The Department of Transportation, Federal Highway Administration (FHWA), Eastern Federal Lands Highway Division (EFLHD) served as a cooperating agency in the preparation of the EA.

The document includes information from various technical studies including those related to wetlands, threatened and endangered species, air quality and noise impacts. In compliance with the National Historic Preservation Act, Section 106 and 36 Part 800, information concerning potential effects of the proposed project on properties listed in or eligible for listing in the National Register of Historic Places is also provided in the environmental documentation.

The project will continue to be coordinated with appropriate federal, state and local agencies as part of the environmental review and approval processes required throughout project development and construction. All required environmental clearance and permits will be obtained prior to construction. Strict compliance with all environmental conditions and commitments resulting from regulatory approvals, and implementation of VDOT's specifications and standard best management practices will protect the environment during construction.

The NEPA document and the results of other environmental studies are available at today's meeting. Representatives from VDOT's Environmental Section are available to discuss this information and to answer questions.

Right of Way

The construction of the Air Terminal Interchange Eastern Intersection project will require acquisition of easements for roadway and drainage facilities. Right of Way acquisition and utility relocation will be performed in accordance with the Federal Uniform Relocation and Real Property Acquisition Act and VDOT standards.

Displays at this meeting show the extent of easements that may be needed as the project moves forward. As the final design is developed, additional easements may be required beyond what is shown on the plans. Property owners will be informed of the exact location of the easements during the right of way acquisition process prior to construction.
