# **Project Overview**



Route 29 and Route 703, Chatham, VA

Available Allocations - \$11.4 Million
Purpose – Improve safety and operations
From – 0.048 mile east of Route 29
To – 0.066 mile west of Route 29
Project Length – 0.114 mile
Improvements –

- Construct a left turn lane on Tightsqueeze Rd.
- Construct a right turn lane on Fairveiw Rd.
- Install lighting and rumble strips at the intersection
- Relocate the signal poles out of the median and adjacent to Route 29
- Install a raised median on a portion of Tightsqueeze Road to reduce conflicts too close to the intersection.

# PROJECT DESCRIPTION

The existing and adjacent intersections along Route 29 are prone to operational issues and congestion during peak demand periods. The purpose is to reduce conflict points by eliminating median crossovers to address safety and congestion on a Virginia Corridor of Significance. An RCUT was approved through Smart Scale.

After the public hearing notices were published in the local newspapers and the notifications per the Public Involvement Manual were mailed, citizens began responding via email to the project manager, the residency, and their local Board of Supervisors (BOS) in opposition of the proposed RCUT.

In fact, the BOS received so many complaints regarding the proposed RCUT that the County Administrator wrote a letter dated May 16, 2023, to the Assistant Resident Engineer of the Halifax Residency requesting that VDOT abandon the planned improvements for the project.

A proposed alternative to the RCUT that will address the safety and operations needs of the intersection was devised and shared with the BOS on July 18, 2023.

The BOS requested a Citizens Information Meeting (CIM) for the proposed alternative to gauge the public's response prior to requesting the proposed alternative be advanced. The proposed alternative consists of adding a left turn lane on Tighsqueeze Rd. and a right turn lane on Fairview Rd.

The design of this project will be in compliance with the Stormwater Management Act, stormwater regulations and the annual stormwater management standards and specifications approved by the Virginia Department of Conservation and Recreation. Potential impacts to the flood plains will be evaluated and addressed on this project.

The construction of this project will conform to the nationwide best management practices, VDOT specifications and special provisions, and the Virginia Department of Soil and Water conservation regulations. Also, during construction, every reasonable effort will be made to protect the environment with respect to dust and erosion control.

After this meeting, information regarding right of way process may be obtained from the right of way contact listed on the back of this brochure.

#### **Anticipated Schedule**

The schedule is dependent on the Board of Supervisors' request to advance the proposed alternative. If the project advances, a schedule will be developed based on the revised start date.

#### **Environmental Review**

If the project advances, VDOT's Lynchburg District Environmental Office will perform environmental reviews and coordination to obtain information about environmental resources in the project vicinity; to provide natural and historic resource agencies an opportunity to review and comment on the project during its development; and to identify opportunities for avoidance, minimization and mitigation of potential environmental impacts.

The National Environmental Policy Act (NEPA) is applicable to this project and a NEPA document in the form of a Programmatic Categorical Exclusion will be developed in cooperation with the Federal Highway Administration and in accordance with federal guidelines. The NEPA document will include information from various technical reviews including those related to natural resources, water quality, cultural resources, threatened and endangered species, air quality, noise, etc.

If the project advances, the project will continue to be coordinated with the appropriate federal, state, and local agencies as part of environmental review and approval processes required throughout project development and construction. All required environmental clearances will be obtained prior to commencement of construction. Strict compliance with all environmental conditions and commitments resulting from regulatory approvals, and implementation of VDOT's specifications and standard best management practices will protect the environment during construction.
